Pursuant to the provisions of section 620.109, Florida Statutes, this Ohio limited partnership, whose certificate was filed with the Florida Department of State on August 20, 1993, adopts the following certificate of amendment to its certificate of limited partnership:

FIRST: Amendment: Sections 1.2 and 1.3 of the Partnership Agreement are hereby amended by deleting Sections 1.2 and 1.3 in their entirety and replacing them with the following:

Section 1.2 Name. The name of the Partnership shall be C-130 Power Master Limited Partnership.

Section 1.3 General Partner. The Partnership Agreement is hereby amended to provide for the admission of additional general partners with the consent of the General Partner and Limited Partners holding a majority of the Units. In the event of the withdrawal of a general partner, the business of the Partnership may be carried on by the remaining general partner. Effective July 31, 1996, C-130 Power Master Limited Liability Company, an Ohio limited liability company (referred to herein as the "Additional General partner" or "General Partner") agrees to become, and is admitted as a general partner of the Partnership. Effective July 31, 1996, Snow Aviation International, Inc. withdraws as general partner of the Partnership. MA 6-285
