Dear Ms. Tadlock:

I am writing to ask you to consider waiving the second set of reinstatement fees for our three entities registered in Florida:

1. Juniper Partners Limited Partnership (Ref. Number B93000000492)
2. Juniper Eventide Limited Partnership (Ref. Number B95000000159)
3. Juniper Michael Limited Partnership

We started the reinstatement process back in October 2001. At that time Juniper Eventide and Juniper Michael sent checks for 2001 annual report and reinstatement fees. The checks were returned with a letter stating that Juniper Partners, LP who is the general partner of the two entities needed to be reinstated first. We were not informed of the extra \$500.00 reinstatement fees for neither of the entities, so we tried to reinstate the general partner and we also resent the checks for Juniper Michael and Juniper Eventide without the extra fees. All checks were returned again. We attempted to find out the reason for the checks being returned, and during the telephone conversation with the State on May 14, 2002 we were again informed that the fees were \$782.50 for Juniper Partners, \$1,152.50 for both Juniper Eventide and Juniper Michael. The checks were returned on June 6, 2002, and only then were we informed about the second set of reinstatement fees.

We have been impaired to do certain business activities due to this lengthy process of getting our entities reinstated and so are asking you to help us overcome this problem. As per our telephone conversation, I am enclosing three checks: \$782.50 for Juniper Partners, \$1,552.50 for Juniper Eventide, and \$1,552.50 for Juniper Michael.
