The General Partners of the Partnership were Simon Property Group, Inc., a Delaware corporation, filed with the Florida Secretary of State under F98000001489, and SPG Properties, Inc., a Maryland corporation, filed under F93000005728.

SPG Properties, Inc. filed Articles of Merger into Simon Property Group, Inc. with the Delaware Secretary of State effective as of July 1, 2001, and thereafter filed a withdrawal with the Florida Secretary of State on November 19, 2001.
