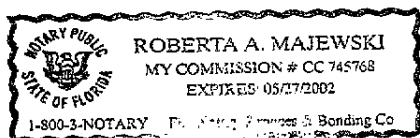

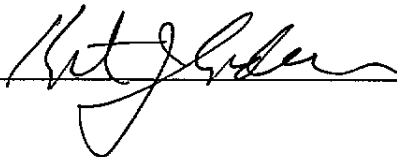

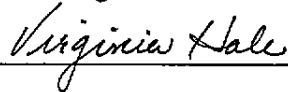
WHEREAS, REBECCA E. NEWMAN is a limited partner of the partnership owning a one percent interest therein;

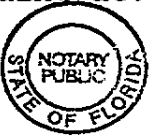
