Thank you for your assistance in providing me with an opportunity to request a review of the "non-filing" status of the 2003 UBR for the foregoing entity.

I have enclosed copies of the records for both Napier West Florida Limited Partnership and Napier Venice Limited Partnership. As you can see, both LPs have the same GP and are one document number apart in their filing. It would appear the Napier Venice UBR and fee payment was processed correctly, but when Napier West was processed immediately thereafter, the system generated a tracking number for payment (000016781500), but never actually updated the record nor processed the payment. For your information, the manner of payment was a debit card from Bank of America, #4635760001651573, expiring 02/08. The same card was utilized for Napier Venice, and was properly debited on 4/24/03.

However, in order to avoid any delay in the reinstatement of Napier West, I am enclosing a check in the amount of \$2,052.50, representing filing fees for 2003 and 2004, as well as the penalty fee.

I am at a loss as to how this snafu occurred, but I would formally request that the Division of Corporations reinstate Napier West Florida Limited Partnership, Document Number: B9700000140, and refund the penalty fee of \$1,000.00.
