Please note that we have RETURNED your checks totaling \$782.50 which cover the REINSTATEMENT, but we have RETAINED the \$61.25 payment sent for the AMENDMENT.

BOTH the amendment and the reinstatement are being returned UNFILED.

The problem is the GENERAL PARTNER.

When this partnership filed with us on September 2, 1997, it named AMRESKO MORTGAGE CAPITAL, INC. (F95000000115) as its general partner.

On 9/23/97, the corporate general partner changed its name to AMRESKO CONSOLIDATION CORP.

On the same date, another corporation called HOLLIDAY FENOGLIO, INC. (F94000004073) changed its name to AMRESKO MORTGAGE CAPITAL, INC.

Both the REINSTATEMENT and AMENDMENT documents you have submitted list AMERESCO MORTGAGE CAPITAL, INC. as the general partner.

EITHER this is a mistake, and the general partner is supposed to be the corporation now known as AMRESKO CONSOLIDATION CORP.

OR the general partner really is a corporation called AMERESCO MORTGAGE CAPITAL, INC., in which case, it is NOT the same corporation that was originally listed as the general partner, and an AMENDMENT would have to be filed to change the general partner to this different corporation.

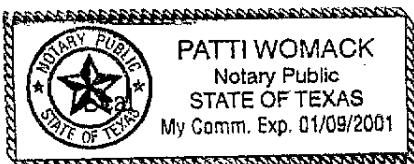
