
Dear Ms. Cushings:

This letter is to confirm a conversation that Grace Thyn, Legal Specialist for Vitas Healthcare Corporation had with you on October 7, 1998, in which you discussed the Application by Foreign Limited Partnership for Authorization to Transact Business in Florida (the "Application") for Vitas Healthcare of Texas, L.P. ("Vitas of Texas"). Ms. Thyn explained that Vitas of Texas is a Texas limited partnership that was formed in September 1998. Vitas Healthcare Corporation ("VHC") is the general partner and Vitas Holdings Corporation ("Holdings") is the limited partner of Vitas of Texas. The principal place of business for Vitas of Texas is in Florida. Services that are provided by Vitas of Texas, as well as the assets of the limited partnership are located in Texas.

It is our understanding that although Chapter 620 of the Florida Statutes requires that a foreign limited partnership register under a name that includes the word "Limited" or the abbreviation "Ltd.," Vitas of Texas may register as Vitas Healthcare of Texas, L.P. As such, it is unnecessary to file an assumed name with the State. It is also our understanding that since the current capital contribution of Holdings is currently \$99.00 and there is no amount of the capital contribution allocated for transacting business in Florida, Vitas of Texas need only pay the minimum filing fee of \$52.50 plus \$35.00 for the registered agent fee. Following any additional capital contribution by Holdings, Vitas of Texas will be required to file a supplemental affidavit with the State. The applicable fee that would need to accompany the supplemental filing would be based on the amount of the capital contribution allocated for transacting business in Florida, if any.

Unless we hear from you to the contrary, we will assume that our understandings are correct and no other action by Vitas of Texas is required in connection with filing the Application. If any of our understandings are incorrect or if you require any additional information, please do not hesitate to contact me at (305) 350-6074.
