We recently received a letter from your office dated June 14, 2000 regarding the above referenced entity. The letter states that we filed our supplemental affidavit and annual report/uniform business report with an incorrect payment. The letter states the total fee due for both filings is \$1,752.64. We originally sent in a payment for \$526.25 (check #12553). After receiving a notice from your office dated May 12, 2000 stating we owed an additional \$1,226.39, we mailed in a second check for \$1,226.39 (check #12929). The total of these two checks equals \$1,752.64.


The total amount of the capital contributions of the limited partners that is allocated for the purpose of transacting business in Florida is \$1,257,559.
