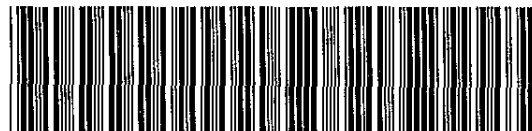

1999 IRREVOCABLE TRUST AGREEMENT

THIS 1999 IRREVOCABLE TRUST AGREEMENT, entered into by and among MYRA K. HALEY and JOHN D. HALEY, Brevard County, Florida, as Settlers (hereinafter referred to as the "Settlers"), and, MILES D. IGO, Brevard County, Florida, as Trustee (hereinafter referred to as the "Trustee"), WITNESSES:

WHEREAS, the Settlers shall deliver to the Trustee certain property as set forth in Schedule "A" attached hereto to be held, in trust, for the uses and purposes and upon the terms and conditions hereinafter stated; and

WHEREAS, the Trustee is willing to act as trustee of the trust created by this Irrevocable Trust Agreement, which may be known as the "1999 Irrevocable Trust."

NOW, THEREFORE, in consideration of these premises and the mutual promises and covenants contained herein, the Settlers and the Trustee agree that the Trustee shall take and hold such property, together with all proceeds, investments and reinvestment thereof, and additions of other property acceptable to the Trustee which may be or become a part of the trust property (all hereinafter referred to as the "Trust Property"), and shall hold, manage, invest and distribute the Trust Property in accordance with the provisions of this Irrevocable Trust Agreement.

ARTICLE I

In connection with the administration of any trust created hereunder, this Irrevocable Trust Agreement shall be construed in accordance with the following terms and provisions:
