



TO THE HONORABLE JUDGES OF THE CIRCUIT COURT OF THE FIRST
JUDICIAL CIRCUIT OF FLORIDA, IN AND FOR ESCAMBIA COUNTY:

WE, THE UNDERSIGNED HEREBY ASSOCIATE OURSELVES TOGETHER FOR THE PURPOSE
OF BECOMING INCORPORATED UNDER THE LAWS OF THE STATE OF FLORIDA, APPLICABLE
TO CORPORATIONS NOT FOR PROFIT, UNDER THE FOLLOWING PROPOSED CHARTER:

ARTICLE I.- NAME

THE NAME OF THE CORPORATION SHALL BE "PENSACOLA BAY BAPTIST ASSOCIATION"
AND IT IS TO BE LOCATED IN ESCAMBIA COUNTY, FLORIDA.

ARTICLE II.- OBJECT

THE GENERAL NATURE OF THE CORPORATION SHALL BE TO;

(A) TO PROMOTE THE SPIRIT OF UNITY AND GOOD FELLOWSHIP AMONG SISTER
BAPTIST CHURCHES IN ESCAMBIA COUNTY, FLORIDA, ACTIVELY CO-OPERATING WITH THE
FLORIDA BAPTIST CONVENTION AND THE SOUTHERN BAPTIST CONVENTION:

(B) TO AFFORD A MEDIUM OF CO-OPERATION FOR THESE CHURCHES IN THE
PROMOTION OF THEIR COMMON INTERESTS, AND THE SERVING OF THE INTERESTS OF THE

THE MESSENGERS FROM THE RESPECTIVE CHURCHES SHALL BE ELECTED ANNUALLY BY THE CHURCHES FROM THEIR MEMBERSHIP AND SEATED AT THE ANNUAL MEETING OF THE ASSOCIATION. ALL MESSENGERS ARE TO BE CERTIFIED TO THE ASSOCIATION BY THE INCLUSION OF THEIR NAMES IN THE CHURCH LETTER.

CHURCHES SHALL MAKE ANNUAL REPORTS TO THE ASSOCIATION ON THE LETTER FORM PROVIDED BY THE ASSOCIATION. ANY CHURCH FAILING FOR THREE CONSECUTIVE YEARS TO MAKE SUCH REPORTS SHALL BE CONSIDERED AS HAVING WITHDRAWN FROM THE ASSOCIATION AND SHALL BE DROPPED FROM THE ROLL THEREOF, PROVIDED THE EXECUTIVE COMMITTEE SHALL HAVE COMMUNICATED WITH THE CHURCH EACH YEAR RELATIVE TO ITS FAILURE TO REPORT.
