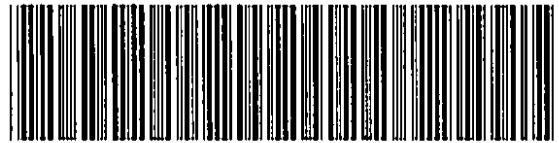

**AMENDMENT OF DECLARATION OF TRUST**

**April 8, 2019**

I, Lois M.
