Midland Affordable Housing Group Trust

This Fourth Amendment ("Amendment") to the Amended and Restated Agreement and Declaration of Trust for Midland Affordable Housing Group Trust (the "Group Trust") is entered into as of October 20, 1999, by and among Wayne County Employees' Retirement System, a body politic of the State of Michigan, City of Detroit Policemen and Firemen Retirement System, and General Retirement System of the City of Detroit (collectively, the "Participating Trusts") and Robert J. Banks, Keith J. Gloeckl, Ray F. Mathis, and Alfred D. Bricker (collectively, the "Trustees").

- A. The Group Trust was created pursuant to that certain Agreement and Declaration of Trust dated December 1, 1991 (the "Original Agreement") and existing pursuant to the Original Agreement as amended and restated by that certain Amended and Restated Agreement and Declaration of Trust dated as of January 1, 1992 (the "Amended and Restated Agreement"), and is organized to afford its Participating Trusts (as hereinafter defined), which are (i) trusts that individually for a part of and employer's pension or profit-sharing plan for employees that are exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended (the "Code") by reason of qualifying under Section 401(a) of the Code, (ii) governmental plans as defined in Section 414 (d) of the Code, and/or (iii) governmental units as described in Section 818(a)(6)(B) of the Code, the opportunity to pool a portion of their assets for investment, primarily for the organization and acquisition of mortgage loan investments, in accordance with the terms and conditions of the Amended and Restated Agreement.
- B. The Amended and Restated Agreement was filed in the Office of the Secretary of State of the State of Florida on February 25, 1992 as Document #D00115.
- C. The Amended and Restated Agreement was modified by the First Amendment to Confidential Private Placement Memorandum and Amended and Restated Agreement and Declaration of Trust, which amendment is dated as of January 1, 1994, and which was filed in the Office of the Secretary of State of the State of Florida on July 31, 1995 (the "First Amendment").
- D. The Amended and Restated Agreement was modified by the Second Amendment to Midland Affordable Housing Group Trust Confidential Private Placement Memorandum, which amendment is dated as of December 1, 1995, and which was filed in the Office of the Secretary of State of the State of Florida on October 2, 1997 (the "Second Amendment").
- E. The Amended and Restated Agreement was modified by the Third Amendment to Midland Affordable Housing Group Trust Confidential Private Placement Memorandum, which amendment is dated as of October 1, 1997, and which was filed in the Office of the Secretary of State of the State of Florida on December 16, 1997 (the "Third

Amendment").

F. The Participating Trusts and the Trustees desire to further amend the Amended and Restated Agreement as set forth herein.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned, constituting all of the Trustees of the Trust and all of the Participating Trusts, hereby further amend the Amended and Restated Agreement, as previously amended by the First Amendment, the Second Amendment and the Third Amendment, as follows:

1. The first sentence of Section 8.4 of the Amended and Restated Agreement is hereby deleted (as shown below) and the following (in italics) is inserted in its stead:

There shall be at least one but not more than four Trustees.

There shall be at least one but not more than five Trustees.

2. The following sentence (in italics) is added to the end of Section 8.4 of the Amended and Restated Agreement:

Upon the death, resignation, or removal of a Trustee, the Board of Trustees may elect to reduce the size of the Board of Trustees by the number of deceased, resigned, or removed trustees; provided, however, there shall be at least one Trustee at all times. Thereafter, the Board of Trustees, by unanimous action, may increase the size of the Board of Trustees; provided, however, there shall be no more than five Trustees.

- 3. The Participating Trusts hereby ratify the Amended and Restated Agreement as modified by the First Amendment, the Second Amendment and the Third Amendment and as further modified by this Amendment and ratify all action heretofore taken in the name of the Trustees of the Group Trust notwithstanding that more than four trustees might have been named to hold the position as a trustee of the Group Trust prior to the date hereof.
- 4. The size of the Board of Trustees (unless adjusted hereafter as provided for herein) is increased to five. The Trustees hereby name Michael L. Falcone as a trustee of the Group Trust. Therefore, the following are the Trustees of the Group Trust:

Robert J. Banks Keith J. Gloeckl Ray F. Mathis Alfred D. Bricker Michael L. Falcone

5. This Amendment may be executed in one or more counterparts, each of which shall be

deemed to be an original copy and all of which together shall constitute one agreement binding on all parties hereto, notwithstanding that all of the parties shall not have signed the same counterpart.
