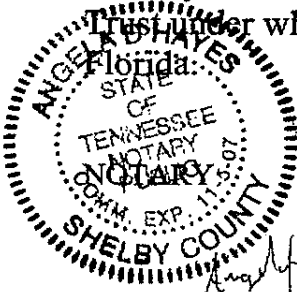

It is the intent of the trustees to acquire office space or land in Florida as soon as feasibly possible.

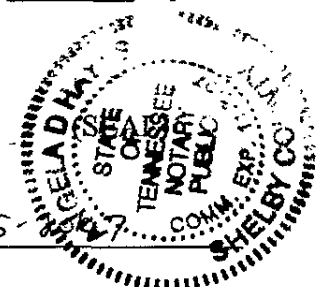
