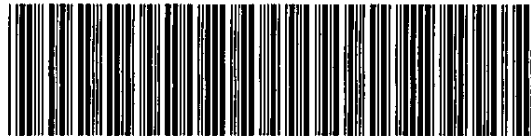

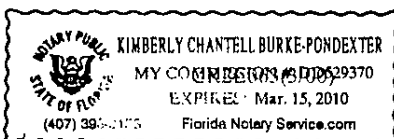

At this, the first meeting of the Board of Trustees of This Trust Organization held in the State of Florida at PO Box 1653, Deerfield Beach, FL 33443 on the 25th day of April, 2007.

All the Trustees being present, by unanimous accord the following was affirmed and ratified, vis:

1. That, pursuant to the request and declaration of **Benjamin Gomillion** on this date, a Trust Indenture creating, a Pure Trust Organization, was duly executed, acknowledging **Benjamin Gomillion** as the Creator (and as Trustee) of This Trust Organization and **Benjamin Gomillion, Emma Gomillion & Valeria Kelly**, its other Trustees, and the above named persons by their signatures evidence the acceptance of the duties, obligations and faithful performance of Said Trust.



GOD'S STOREHOUSE is domiciled in Florida and formed under the laws and Constitution of Florida and the common laws and Constitution for the united States of America.



