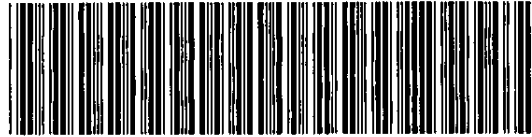





At this meeting of the Board of trustees of this Organization held in the City of Budapest, Hungary, on the 1st day of April 2016.


All the Trustees being present, by unanimous accord the following was affirmed and ratified, vis:


1. That, on the March the 20th 2013 a meeting of the Board of Trustees was held in the City of Budapest, Hungary; and below listed agenda items were accepted and acknowledged:
 - a. *That, on the February the 18th 2013 the FedAIRation Holding Inc., company address: 3801 South Ocean Drive, Apt. N4X, Hollywood, FL, 33019 USA, reg. No P13000015731 had been founded, the property of which comprises a know-how in the estimated value of 250 000 000 (two hundred fifty million) US Dollars, and this property had been invented by László Csiky and commonly developed by László Csiky, Zsolt Hajdu and Katalin Szathmáry.*
 - b. *That, the asset (know-how) forming the property of FedAIRation Holding Inc., was divided into 250 million pieces of shares in the estimated value of 1 US Dollar each, and the inventors and developers of the know-how were regarded as owners of FedAIRation Holding Inc. in the above mentioned proportion.*

- c. *That, Péter Lévai, Sándor Szikszai and László Verécsi, all original founders of FedAIRation Holding Inc., who had been expected to develop and execute the know-how of FedAIRation Holding Inc. failed to fulfill their obligations therefore the full volume of their shares (100 000 000 pieces in total) has been transferred into this Trust as of the below date.*
- d. *That, above László Csiky and Zsolt Hajdu had decided to transfer the entire volume of their shares (150 000 000 pieces in total) in FedAIRation Holding Inc. into this Trust.*
- e. *That, by the transfer of assets described in points c. and d. this Trust had become sole proprietor of in FedAIRation Holding Inc. as approved unanimously by the Board of Trustees.*
2. That, none of above listed, previously adopted motions was performed.
3. That, as a consequence, László Csiky is hereby terminated as beneficiary of this Trust and thus, a modification will be recorded accordingly in Schedule "C" Capital Unit Certificate Holders, as approved unanimously by the Board of Trustees.
4. That, as a consequence, Katalin Szathmáry is hereby also terminated as beneficiary of this Trust and thus, a modification will be recorded accordingly in Schedule "C" Capital Unit Certificate Holders, as approved unanimously by the Board of Trustees.
5. That, as a consequence, by the failure of the fulfilment of the transfer of assets described in points c. and d. this Trust is hereby terminated as sole proprietor of in FedAIRation Holding Inc. as approved unanimously by the Board of Trustees.
6. That, as a consequence, Zsolt Hajdu in his capacity of First Trustee of this Trust hereby terminates László Csiky as Trustee of this Trust; the termination has been approved unanimously by the Board of Trustees. The termination of this role will be recorded accordingly in attachments and made part of this Trust's records.
7. That, as a consequence of failure of the accomplishment of the project, and agenda items a.-f., all of the modifications made on the March the 20th 2013 are hereby repealed, and the original status quo of Capital Units and Personal Property is hereby restored. The terminations described in point 3.-6. of this Minutes shall take immediate effect, as of the below date.
8. That, upon motion duly made by the First Trustee and approved by the Board of Trustees, it was resolved, that there are modifications to the Schedule "B" Personal Property and to the Schedule "C" Capital Unit Certificate Holders, and that these modifications of this Minutes have been performed.

There being no further business to discuss, the meeting was adjourned.
