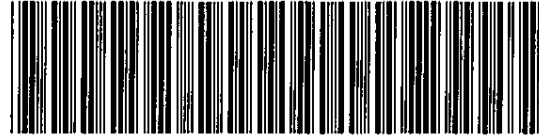



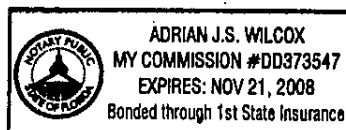

**TRUST AGREEMENT AND DECLARATION OF  
TRUST ESTABLISHING  
NEW WINE FELLOWSHIP TRUST**

THIS TRUST AGREEMENT made and entered into this 14th day of May, in the year of our Lord, 2008, by and between NEW WINE FELLOWSHIP CHURCH, (hereinafter referred to as the "Church") and Richard Vasquez, Adrian Wilcox, Joel Molina and Patrick Lafferty, residents of Palm Beach County, Florida, as trustees (hereinafter referred to as "trustees" or "the Board of Trustees") does hereby establish a trust under the name "NEW WINE FELLOWSHIP TRUST".

ARTICLE 1. The Church, recognizing that Christian people are called to be faithful stewards of all the gifts of God — time, abilities, the created world, and money, including accumulated, inherited and appreciated resources — has made an initial and irrevocable gift of \$1,000 to establish this trust.

ARTICLE 2. This Trust is created for the purpose of expanding and enriching the mission and ministry of New Wine Fellowship Church, locally and globally, and to assist in any capital improvements which may be made to its facilities used for worship, nurture, and other congregational ministries.

ARTICLE 3. The Trustee shall hold, manage, invest and reinvest the trust property, and shall collect and receive the income thereof, and after deducting all necessary expenses incident to the administration of the trust, shall dispose of the principal and income of the trust as follows:

- a) The property is to be distributed by the Trustee to the Church as needed or requested by the Board of Elders, and at their discretion;
- b) It is the further intent of the Church that the income shall be used by the New Wine Fellowship Church for capital expenditures or for increased giving to mission and outreach causes of the Church;
- c) The Church, at the discretion of its Pastor, and with the support of the Board of Elders may request funds to exercise support or opposition to public policy with regards to politics, moral, ethical or spiritual matters deemed to be of interest of the Body of Christ.

ARTICLE 4. It is agreed that additional contributions may be made to this trust fund by the Church from undesignated bequests made to the Church or from bequests which specify that they are to be used to fund this trust, or from any other sources.

ARTICLE 5. The Trustee agrees to exercise and follow prudence in the investment of the principal and to see that an annual report is made to the Church on this trust, income received, and capital gains, if any, added to the fund, as well as additional gifts added to the fund by the Church or from any other source.

ARTICLE 6. In the administration of this trust, the trustees, in the exercise of a reasonable discretion with respect to all property, real and personal, at any time forming a part of said trust, shall have the right and power to exercise any or all powers set forth in Florida Statutes to the extent applicable, all of which provisions and powers are incorporated herein by reference as fully as if copied herein verbatim.

ARTICLE 7. The Trustees herein accepts said trust, and waives the payment of any compensation for its services hereunder.

ARTICLE 8. In the event, the New Wine Fellowship Church should cease to exist, the Church hereby directs that the Trustees disburse the income from the trust as follows: one-half for the support of ministerial education in the form of educational grants and one-half for the support of missionaries serving the New Wine Fellowship Church outside the continental United States.


ARTICLE 9. Said trust shall be irrevocable, and the Trustee shall not be required to give bond or any other security.


ARTICLE 10. This agreement may be amended at anytime by majority vote of the seated trustees.
