

#### CERTIFICATE OF TRUST OF GE CF TRUST

This Certificate of Trust of GE CF Trust (the "Trust"), dated as of June 4, 2009 (the "Certificate of Trust"), is being duly executed and filed by the undersigned, as Trustees, to form a statutory trust under the Delaware Statutory Trust Act (12 Del. C. § 3801 et seq.) (the "Act").

1. Name. The name of the statutory trust formed hereby is GE CF Trust.

2. <u>Delaware Trustee</u>. The name and business address of the Trustee of the Trust in the State of Delaware is Wilmington Trust Company, 1100 North Market Street, Wilmington Delaware 19890, Attention: Corporate Trust Administration.

3. <u>Duly Authorized</u>. The Trustee is duly authorized to sign this Certificate of Trust.

- 4. <u>Series</u>. Pursuant to Section 3806(b)(2) of the Act, the Trust shall issue one or more series of beneficial interests having the rights and preferences set forth in the governing instrument of the Trust, as the same may be amended from time to time (each a "<u>Series</u>"). Separate and distinct records shall be maintained (directly or indirectly, including through a nominee or otherwise) for each Series, and the assets of each Series shall be held and accounted for separately from the assets of the Trust generally or any other Series.

- Power of Attorney. Without limiting the generality of the foregoing, GE Capital or any GE Capital Designee is hereby authorized and empowered by the Trust to execute and deliver, on behalf of the Trust, any and all applications for certificates of title or duplicates of such certificates in the name of the Trust, any and all applications for registrations of vehicles and/or license plates, any and all applications for transfers of certificates of title or registrations for vehicles and/or license plates, and any and all other instruments, certificates or other documents which GE Capital or a GE Capital Designee deems necessary or advisable to record, hold or release title to and/or registration of motor vehicles in the name of
