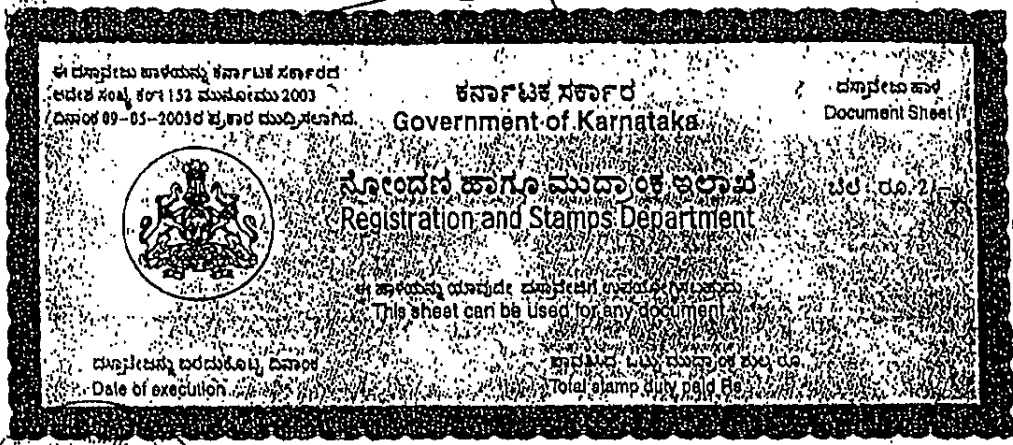

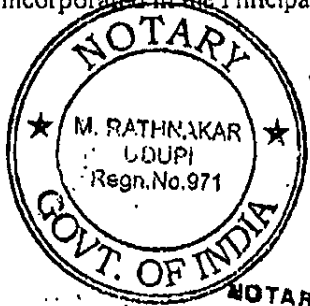
DEED OF AMENDMENT OF TRUST

THIS DEED OF AMENDMENT is executed on this the 24th day of September 2004 by Manipal Academy of Higher Education, (hereinafter referred to as 'MAHE') a registered Charitable Trust represented herein by its Trustee & President Dr. Ramdas M Pai, aged about 69 years, Son of Late Dr. TMA Pai, residing at Manipal of Udupi Taluk, Udupi District, Karnataka State.

WHEREAS the Trust named above was created by Dr. Ramdas M Pai in terms of the Deed of Trust dated 19th May 1993 and registered in the Office of the Sub-Registrar, Udupi on 22nd May, 1993 as Document No. 5 of 1993-94, Volume 89 of Book No. IV, pages 145 to 160 (hereinafter called as the 'Principal Deed') whereby the author of the Trust transferred a sum of Rs. 1,000/- as nucleus of the Trust Fund. AND

WHEREAS the Board of Trustees of MAHE have unanimously resolved at their meetings held on 1st April 2002 and 6th February 2003 to amend the Principal Deed in the manner detailed in this Deed, in terms of the powers vested in them under Clause 20 of the Principal Deed, in order to efficiently and successfully achieve the objects of MAHE and authorized Dr. Ramdas M Pai to execute this Deed of Amendment on behalf of the Trust and present the same for registration, NOW THEREFORE, the following amendments mentioned herein should be read and treated as being inserted and incorporated in the Principal Deed :-

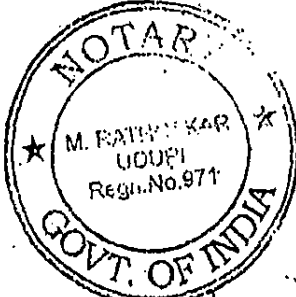

1. The following clause shall be added as Clause 19mm of the Principal Deed : " To purchase and or sell shares, stock, debentures, securities and /or any other financial instruments including derivatives and to undertake interest rate and currency swaps, options, swap option contracts, forward exchange contracts, forward rate agreements, futures contracts or other financial instruments including hedging agreements and derivatives of any kind, all or any of which may be on a fixed and or floating rate basis and or in respect of Rupees , any other currencies, basket of currencies or commodities of any kind, subject to all applicable laws, rules and regulations. "

2. The following clause shall be added as Clause 19mmm of the Principal Deed : " To permit and or offer the immovable of movable assets, whether fixed or current or floating or in any form including the revenues, receivables, cash flows of the Trust to be mortgaged, charged, hypothecated or encumbered in any manner as the Trustees deem fit and or issue guarantees to any Banks, Financial Institutions or others, on such terms and conditions as the Trustees may think proper and expedient, as security for the purpose of obtaining credit facilities for the Trust or for any other entity. Powers under this clause are exercisable only by a resolution by 2/3 majority in the meeting of the Board of Trustees".

3. The consequent effect of the above amendment will be change in clause 14 of the Principal Deed of Trust which shall read as below :-

All decisions of the Board of Trustees shall be by simple majority of the Trustees as are present and voting at a duly convened meeting except regarding co-opting of a new Trustee and as regards transfer of any property of the Trust or giving guarantees to any Banks and Financial Institutions as Security for the borrowings of the Trust or any third party and amendments to the Trust Deed for which special provisions have been made in clauses 19(I), 19mmm and 20 herein. If an equal number of votes is registered for or against a resolution moved or proposal made at the meeting, the Chairman of the meeting shall have a second or casting vote. "

9. The properties of the Trust shall be vested and managed by the Board of Trustees. The Board of Trustees shall consist of not less than 5 but not exceeding 15 members.

PRESIDENT OF THE TRUST :

10. There shall be a Chief Executive elected from among the Trustees themselves who shall be responsible for the day-to-day activities of the Trust, subject to the supervision of the Board. He shall be designated as the President of the Trust. The powers and duties of the President shall be defined by the Board from time to time.

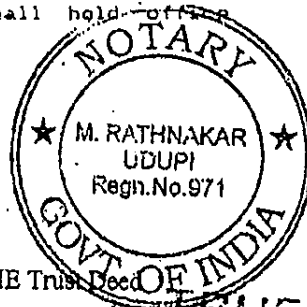
The Board also shall elect one of the Trustees as Chairman of the Board of Trustees, who shall preside over meetings of the Board and who shall hold office for five years at a time.

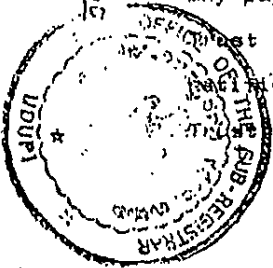

18. A member of the Board of Trustees is free to resign and he shall cease to be a Trustee upon the acceptance of his/her resignation by the Board.

POWERS OF THE BOARD OF TRUSTEES :

19. With a view to carry out the objects of the Trust and to administer the Trust and in discharge of their duties, and without prejudice to the generality of any powers hereby, or by law conferred or implied or vested in the Board of Trustees, the Board of Trustees shall have the following powers :

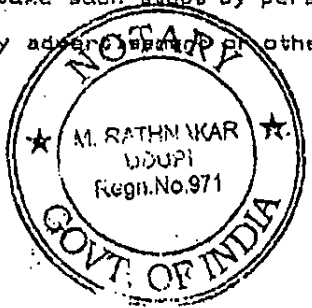
