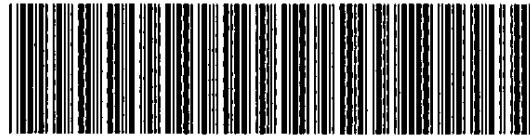

CERTIFICATE OF TRUST OF GIST GLOBAL TRUST

THIS CERTIFICATE OF TRUST OF GIST GLOBAL TRUST (this "Certificate"), dated February 26, 2013, is being duly executed and filed by the undersigned, as trustees, to form a statutory trust (the "Trust") under the Delaware Statutory Trust Act (Chapter 38 of Title 12 of the Delaware Code) (the "Act").

1. Name. The name of the Trust is Gist Global Trust.
2. Series. The Trust may have classes, groups or series of trustees or beneficial owners, or classes, groups or series of beneficial interests, having such relative rights, powers and duties as the governing instrument may provide, and may make provision for the future creation in the manner provided in the governing instrument of additional classes, groups or series of trustees, beneficial owners or beneficial interests, having such relative rights, powers and duties as may from time to time be established, including rights, powers and duties senior or subordinate to existing classes, groups or series of trustees, beneficial owners or beneficial interests (each a "Series"). The debts, liabilities, obligations and expenses incurred, contracted for or otherwise existing with respect to a particular Series shall be enforceable against the assets of such Series only, and not against the assets of the Trust generally or any other Series thereof, and, unless otherwise provided in the governing instrument, none of the debts, liabilities, obligations and expenses incurred, contracted for or otherwise existing with respect to the Trust generally or any other Series thereof shall be enforceable against the assets of such Series.
