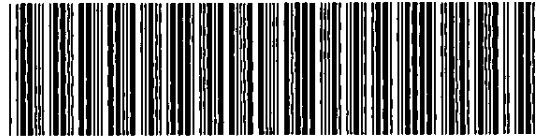

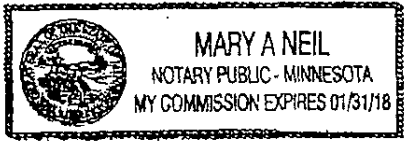



CERTIFICATE OF TRUST OF RYDER WF LEASING

This Certificate of Trust of Ryder WF Leasing (the "Trust"), is being duly executed and filed by the undersigned, as trustee, pursuant to the Delaware Statutory Trust Act (12 Del. Code, § 3801 *et seq.*) (the "Act").

1. Name. The name of the statutory trust formed hereby is Ryder WF Leasing.
2. Delaware Trustee. The name and business address of the trustee of the Trust in the State of Delaware are Wells Fargo Delaware Trust Company, N.A., 919 N. Market Street, Suite 1600, Wilmington, DE 19801.
3. Separate Series. Pursuant to Section 3806(b)(2) of the Act, the Trust will issue one or more series of beneficial interests having the rights and preferences specified in the governing instrument of the Trust, as it may be amended from time to time (each a "Series").
4. Limitation of Liability of Each Series. Pursuant to Section 3804(a) of the Act, the liabilities of each Series shall be limited such that (a) the debts, liabilities, obligations, and expenses incurred, contracted for, or otherwise existing with respect to a particular Series shall be enforceable against the assets of that particular Series only, and not against the assets of the Trust generally, or the assets of any other Series and (b) none of the debts, liabilities, obligations, and expenses incurred, contracted for, or otherwise existing with respect to the Trust generally and any other Series shall be enforceable against the assets of the particular Series.
5. Effective Date. Certificate of Trust shall be effective upon its filing with the Secretary of State of the State of Delaware.
