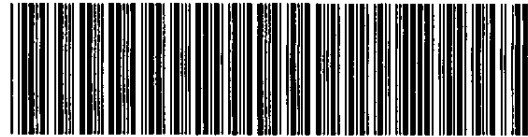



5. Effective Date. This Certificate of Trust shall be effective upon filing.
