AMENDED AND RESTATED CERTIFICATE OF TRUST OF XCL TITLING TRUST

This Amended and Restated Certificate of Trust of the XCL Titling Trust (the "Trust") is being duly executed and filed on behalf of the Trust by the undersigned, as trustee, with respect to a statutory trust formed under the Delaware Statutory Trust Act (12 Del. C. § 3801 et seq.) (the "Act"). The original Certificate of Trust of the Trust was filed with the Secretary of State on March 14, 2016.

- 1. Name. The present name of the statutory trust is the XCL Titling Trust.
- 2. Delaware Trustee. The name and business address of the trustee of the Trust in the State of Delaware are Wilmington Trust, National Association, Rodney Square North, 1100 North Market Street, Wilmington, Delaware 19890 Attention: Corporate Trust Administration.
