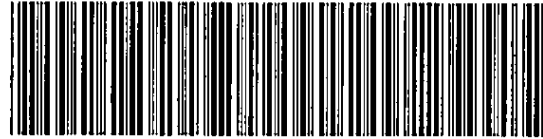

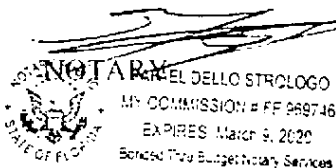

Grantor: CHRISNEL SIMON. ADMIN - (defined) the *grantor* is the person who creates the trust
