DECLARATION OF PRIVATE NON-CHARITABLE NON-EXHAUSTIVE DISCRETIONARY EXPRESS TRUST

Established March 31, 2020, 12:15-12:59 PM -5 Greenwich Mean Time (GMT)

THIS INDENTURE ("Agreement") made this 31st day of March, Two-Thousand and Twenty (2020) anno Domini (AD) serves as a Declaration of Private non-charitable non-exhaustive Discretionary Express Trust and shall continue for a term of twenty-one (21) years from this day, between AIDAN REES LLEWELLYN herein known as the Settlor, and party of the first part, and Llewellyn, Aidan Rees, Trustee, herein known as the First Trustee or Trustee, party of the second part, under the name of AIDAN REES LLEWELLYN EXPRESS TRUST doing business as (hereinafter "dba") "AIDAN REES LLEWELLYN" and "AIDAN REES" and "ALLSTAR CAPITAL" and "ALLSTAR VENTURES" and "THE LLEWELLYN ORGANIZATION". With this Contract, the Parties intend to create a Private Non-Exhaustive Discretionary Express Trust Organization (hereinafter "The Trust") for the benefit of the Trust Certificate Unit Holders and to identify, accumulate, purchase and hold any assets that become available and to provide for a prudent administration and distribution system administered by legal person(s) acting in a fiduciary capacity.

WITNESSETH: Whereas the Settlor, irrevocably assigns and conveys to the Trustee(s), in trust, specific properties as defined in Minutes (1-0001) and (1-0002), attached to this document in exchange for one hundred (100) unit of Beneficial Interest, known hereto as Trust Certificate (TCUs) to be held with this Declaration of Trust by the Trustee(s) for Beneficiary(ies) also known as Members of AIDAN REES LLEWELLYN TRUST dba AIDAN REES LLEWELLYN and AIDAN REES and ALLSTAR CAPITAL and ALLSTAR VENTURES and THE LLEWELLYN ORGANIZATION.

<u>Discretionary:</u> means any distribution is subject to the trustee(s) discretion.

Non-exhaustive: where the trustee(s) have an express power to accumulate income.

<u>Settlor:</u> AIDAN REES LLEWELLYN; (defined) In law a settlor is a person who settles property on trust law for the benefit of beneficiaries. In some legal systems, a settlor is also referred to as a trustor, or occasionally, a grantor or donor. ... A settlor may create a trust by manifesting an intention to create it. grantor is the person who creates the trust.

<u>Trust Protector:</u> IAN NEIL LLEWELLYN, or other person(s) authorized in future by Settlor only; (defined) appointed under the trust instrument to direct or restrain the

- #1. AIDAN REES LLEWELLYN; and
- #2. Any future blood child/childreh/descendants of the Settlor aforementioned in equal shares of The Trust, Name (s) presently unknown, herein known as the Second beneficiary(ies), and other beneficiaries to come in future, and in case where no blood related children are conceived and born, the Second beneficiary shall become the Common Law Wife of the Settlor at the time of death of Settlor, if any, and in the case where the Settlor does not wed or marry under the Common Law or have a wife at time of death; and only after the aforementioned events in this section #2 have transpired and exhausted at the end of the twenty-one (21) years shall the beneficiaries shall then become a cluster of #1 and #3 of this section;
- #3. IAN NEIL LLEWELLYN & KETUT KAYLAN JAYA RICHARDS;

(defined) beneficial owner(s) is where specific property rights ("use and title") in equity belong to a person even though legal title of the property belongs to another person. This often relates where the legal title owner has implied trustee duties to the beneficial owner WHEREAS, the Trust Organization is authorized to exist and function through its Trustee/Board of Trustees, comprised of the total active number of trustees who are legal persons holding fee simple title, not differentiating between legal and equitable, not as individuals, but collectively as the Board, according to the inalienable Common Law rights.

WHEREAS, The Trust shall be amendable, as described in the bylaws, and shall be irrevocable by the Settlor or by any other person or entity but said trustee can be fired by trust protector and replaced by new trustee chosen only by trust protector. It is the intention of the Settlor to make the Beneficiaries, an absolute gift of the Trust Certificate Units, in which the Beneficiaries shall not have any vested interest, until the termination of this Trust and final distribution accumulated assets or any early distribution of the assets thereof. There shall be exactly 100 Trust Certificate Units available to the Beneficiaries.

WHEREAS, The Trust shall be administered, managed, governed and regulated in all respects according to applicable Common Law Jurisdiction of Florida, and the Uniform Commercial Code, and the Convention on Contracts for the International Sale of Goods (CISG), sometimes known as the Vienna Convention, and the Protection of Diplomats Convention, and the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment commonly known as the United Nations Convention against Torture (UNCAT), and the Convention on the Prevention and Punishment of the Crime of Genocide, and the Universal Declaration of Human Rights (UDHR), and the Declaration on the Rights of Indigenous Peoples (UNDRIP), only when and if applicable and/or allowable to remain under the jurisdiction of the Common Law. Greetings Neysa,

Thank you for your efforts yesterday in locating the trust! Very much appreciated.

I was attempting to locate the statute last night where it states that two trustees are required however I was unable to locate it.

I did find something under Chapter 609 about two persons:

Chapter "609.01 Common-law declaration of trust.— Two or more persons, whether residents of this state or not, may organize and associate themselves together for the purpose of transacting business in this state under what is commonly designated or known as a "declaration of trust"; provided, however, no such association shall ever be permitted or authorized to transact a banking or security business, of any kind, in this state."

This legal code does not specifically state that there must be two trustees on the trust. It states that two or more people may organize and associate themselves together.

Here is the trust association and organization breakdown:

Settlor: Aidan Llewellyn Trust Protector: Ian Llewellyn Trustee: Aidan Llewellyn

I believe this satisfies the requirements of Chapter 609.01 as two or more persons are associated in the association and organization of this trust.

Regarding beneficiaries, there are 3 names listed with the possibility of more to become beneficiaries in the future.

If you are able to locate the code that specifically states there must be two trustees please send it for me to review. If not, based on the aforementioned, I believe the trust meets the criteria of Chapter 609.01 above. Lastly, you are likely already aware but just to clarify the trust is to be filed under Chapter 609 and not under Chapter 731-739 therefore Chapters 731-739 do not apply.
