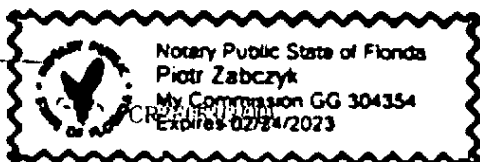

KARL ATHUR BEY TRUST

In this RESOLUTION I, the undersigned currently acting as trustee [hereinafter "Trustee"] having all substantial trust powers, furnish this trust instrument and certify that KARL ATHUR BEY TRUST ["trust"] was formed March 14, 2016. Irrevocable delivery of three silver coins to the first trustee of this trust marked the gift of every right, title and interest held in KUMMER KARL ARTHUR ¹ and KARL ARTHUR KUMMER ² ["Settlor"] ³ including interest in or by every derivative name, number and account.

This RESOLUTION shall continue for the remainder of this trust's twenty-five (25) year term. By entering into this contract I, Dorian Henryk Stanislawski as Trustee ⁴ but not personally, intend to: a) administer KARL ATHUR BEY TRUST for the benefit of the Trust Certificate Unit Holders; b) identify, accumulate, purchase and hold any assets that become available; and c) provide for a prudent administration and distribution system administered by legal persons acting in their fiduciary capacity. This trust is a holding trust created to hold property and control assets from its Common Law situs.

This trust has not been revoked, modified, or amended in any manner that would cause the representations contained herein to be incorrect. Each trustee holds legal title for the true owners of purely equitable title. Based upon the law of this trust, title to trust property is split between the trustee holding legal title to specific property in its legal name and b) the beneficiaries ⁵ holding equitable title. Trustees responsible for managing the trust's assets are authorized by the law of the trust to sign or otherwise authenticate trust documents but each is required to get my approval in order to exercise their powers relating to or bringing about the settlement of an issue or the disposition of trust property.
