DECLARATION OF TRUST
N100GL AIRCRAFT OWNER TRUST

THIS DECLARATION OF TRUST is made on September 30, 2021, by WACO Aircraft Europe, GmbH, a corporation organized under the laws of the State of Delaware as "Settlor" and T-Unlimited, a limited liability company formed under the laws of the State of Florida as "Trustee." The name of the trust established under this Declaration is N100GL Aircraft Owner Trust (hereinafter referred to as the "Trust").

RECITALS

WHEREAS, Settlor and Trustee desire to create a common law trust under the laws of Florida to carry on such general business activity as they deem proper;

WHEREAS, Settlor and Trustee have entered into that certain trust agreement on September 30, 2021 ("Trust Agreement") which is hereby incorporated by reference and Settlor and Trustee agree to govern themselves according to the Trust Agreement; and

WHEREAS, the undersigned is authorized to submit this Declaration on behalf of any party to the Trust Agreement.

DECLARATION

NOW, THEREFORE, Trustee hereby declares the following:

1. The name of the Trust shall be the N100GL Aircraft Owner Trust, and its location shall be 777 Flagler Drive, Suite 800 West Tower, West Palm Beach, Florida 33401.
2. The powers of the Trustee are set forth in the Trust Agreement, and Trustee has been duly authorized to submit this Declaration.
3. The legal and beneficial title to any assets controlled by the Trust shall be governed by the Trust Agreement.
4. The term of the Trust shall be in perpetuity until terminated pursuant to the Trust Agreement.
5. The Trustee may at any time agree to, approve and effect a merger of the Trust into a corporate or other legal entity in accordance with applicable laws.
6. The headings in this Declaration and the groupings of the provisions hereof into separate sections and paragraphs shall not be construed to limit or restrict either the meaning or the application of any provision hereof and are for the purposes of convenience only.
7. All provisions of this Declaration shall be construed in accordance with the laws of the State of Florida.
8. This Declaration shall be binding upon and inure to the benefit of the undersigned Trustee and its successors, assigns, heirs, distributes, and legal representatives.
9. If any provision of this Declaration shall be held invalid or unenforceable in any jurisdiction, such as invalidity or unenforceability shall attach only to such jurisdiction and

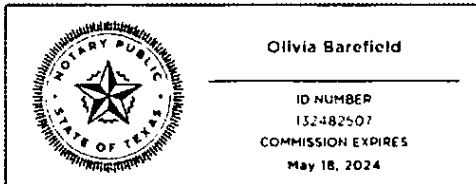
