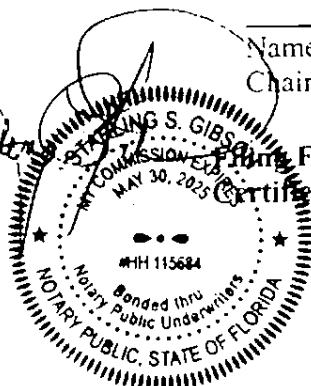

## DECLARATION OF EXPRESS TRUST

Established September 6<sup>th</sup>, 2021, 1:52AM

THIS INDENTURE ("Agreement") made this 6<sup>th</sup> day of SEPTEMBER, 2021 serves as a Declaration of Express Trust and shall continue for a term of twenty-five (25) years from this day, between ROMEL CLARIFON SEMEXANT herein known as the settlor, and party of the first part, and RUMIEL MUNATAS BEY and ALFRED MUHAMMAD BEY "Trustees foreign", herein known as the First Trustee or Trustees, party of the second part, under the name of **RUMIEL MUNATAS BEY EXPRESS TRUST** dba ROMEL CLARIFON SEMEXANT & RUMIEL MUNTAS BEY. With this Contract, the Parties intended to create an Express Trust Organization for the benefit of the Trust Certificate Unit Holders and to identify, accumulate, purchase and hold any assets that become available and to provide for a prudent administration and distribution system administered by legal persons acting in a fiduciary capacity.

**WHEREAS**, the Settlor., **revocable** assigns and conveys to the Trustee(s), in trust, specific properties and specific amendments as defined in Minute (1-0001), to be made in future, this document in exchange for Promissory notes and for one-hundred (100) unit of Beneficial interest, known hereto as Trust Certificates (TCUs) to be held with this indenture by the Trustees for Beneficiaries also known as Members of **RUMIEL MUNATAS BEY EXPRESS TRUST** dba ROMEL CLARIFON SEMEXANT & RUMIEL MUNATAS BEY.

Settlor: ROMEL CLARIFON SEMEXANT – (defined) In law a **settlor** is a person who settles property on **trust** law for the benefits of

Trust Protector: ROMEL CLARIFON SEMEXANT - A person with only and no more than **"merely passive power"** other than trustee, or other person authorize in future by settlor, - (defined) appointed under the trust instrument to direct or restrain the trustees.

Trustee(s): **Bey; Rumiel Munatas and Bey; Alfred Muhammad** (defined) A person or firm that holds or administers property or assets for the benefit of a third party.

Beneficial Owner: **Nya Illi El, Lakaya Marie Hurt, Messiah Thompson, Hassan Thompson, Jeremiah Pope, Isaiah Dalouche, Fallon Leconte, Annaelle Semexant, Mikaelle Semexant & Dainte Jean and Fedorah Pressages** all have equal share of equity ownership rights. This shall remain within trust provision until or unless change is authorize by grantor. The beneficial owners herein known as the First beneficiaries, and other beneficiaries to come in the future (defined) **beneficial owner** is where specific property rights ("use and title") in equity belong to a person even though legal title of the property belongs to another person. This often relates where the legal title owner has implied trustee duties to the beneficial owner(s).

WHEREAS, the Trust Organization is authorize to exist and function through its **Board of Trustees**, comprised of the total active number of trustees who are natural persons who holding **fee simple title absolute**, not differentiating between legal and equitable, not as individuals, but collectively as the Board, according to the inalienable **Common Law rights**.

WHEREAS, The Trust shall be amendable, as described in the bylaws, and shall be **revocable** by the Settlor or any other person or entity but said trustee(s) can be fired by trust protector who holds **only** and **no** more than **"mere passive power"** and replaced by new trustee(s) picked by trust protector. It is the attention of the Settlor to make the

Certificate Units available to the Beneficiaries. The trust has not been **revoked, modified, or amended** in any way that would cause the representations in the trust certificate to be incorrect. This certification is being signed by current trustee(s) and is being executed in conformity with the provisions of **Common Law rights, Jurisdiction and Situs in Taipei City, Taiwan.**

WHEREAS, The Trust shall be administered, managed, governed and regulated in all respects according to applicable (**Common Law Jurisdiction of) Clermont, Florida** as well as the Uniform Trustees Powers Act, Treaty of Peace and Friendship and Treaty of Marrakesh). Court of Chancery or Common Law is the equity court, and the Express Trust can only be heard in Equity court.

The domicile of the trust is within the Equity court, in **Clermont, Florida** in the Republic of the United States of America as a last resort when everything else fails.

WHEREAS, this Express Trust shall **not be**: a Constructive Trust, a Corporate Trust, a Business Trust, a Taxpayer, an Association, A Partnership, an Agency or Charitable Trust, created for Charitable purposes; and

**WHEREAS**, With this contract, the Settlor and parties intend to create an Express Trust Organization, **Situs in Taipei City, Taiwan**, known as the **RUMIEL MUNATAS BEY EXPRESS TRUST** dba ROMEL CLARIFON SEMEXANT & RUMIEL MUNATAS BEY and shall be **revocable** by ROMEL CLARIFON SEMEXANT acting herein as "Settlor foreign" with no more than "**merely passive power**" and shall be authorized to exist, adjudicate, be administered, managed, governed and regulated, as the work and/or act of יהוה [Almighty God], through

authority to control all substantial decisions of this Express Trust and to hold and or administer property or assets for the benefit of the beneficiaries of this Express Trust;

WHEREAS, **No** United States grantor(s), trust protector(s), trustee(s), beneficiaries, or Third Party, shall own this Express Trust; and

WHEREAS, **No** United States Grantor(s), Trust Protector(s), Trustee(s), Beneficial Owner(s), Beneficiaries, or Third Party, Shall; Without Express Trust Written Consent, Produce Any Documentation or Bear Witness of This Express Trust; and

WHEREAS, any conflict of Express Trust Instruments, the Express Trust Declaration and or Indenture as amended, modified, changed or supplemented will control; and

WHEREAS, RUMIEL MUNATAS BEY EXPRESS TRUST, vest in inalienable judicial power, having original jurisdiction in all Law and Equity, without the United States, this Express Trust shall adjudicate, subpoena, issuing formal judgments, decrees and orders in Law and Equity, and said judgments, subpoena, decrees and orders shall have universal standing and full faith and credit resolving disputes or matters in controversy for the benefit, protection and safekeeping of the Beneficiaries and Property of this Trust; and

This Express Trust shall issue Promissory Notes and/or Trust Certificates that delineate the Facial Recognition, Tribal Identity, Race, Nationality, Biometric Data, Administrative Title and Division of Grantor, Trust Protector(s), Trustee(s), Beneficiaries for the benefit, protection and safe keeping of the Beneficiaries and Property of this

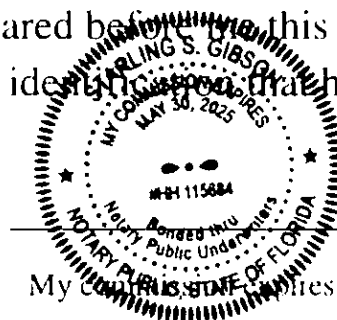

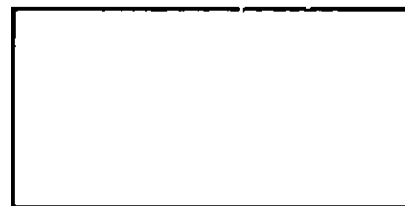
