DECLARATION OF EXPRESS TRUST

THIS INDENTURE ("Agreement") made this Lotton of November, 2021 serves as a Declaration of Express Trust and shall continue for a term of twenty-five (25) years from this day, between LAUTRICE BLAIR McLENDON herein known as the settlor, and party of the first part, NAJIH BEY and ALFRED MUHAMMAD BEY "Trustees foreign", herein known as the First Trustee or Trustees, party of the second part, under the name of NAJIH BEY EXPRESS TRUST dba LAUTRICE BLAIR McLENDON & NAJIH BEY With this Contract, the Parties intended to create an Express Trust Organization for the benefit of the Trust Certificate Unit Holders and to identify, accumulate, purchase and hold any assets that become available and to provide for a prudent administration and distribution system administered by legal persons acting in a fiduciary capacity.

WHEREAS, the Settlor., revocable assigns and conveys to the Trustee(s), in trust, specific properties as defined in Minute (1-0001), to be made in future, this document in exchange for Indemnity Bonds, Money Order, Promissory Notes and/or one-hundred (100) unit of Beneficial interest, known hereto as Trust Certificates (TCUs) to be held with this indenture by the Trustees for Beneficiaries also known as Members of NAJIH BEY EXPRESS TRUST dba LAUTRICE BLAIR McLENDON & NAJIH BEY.
