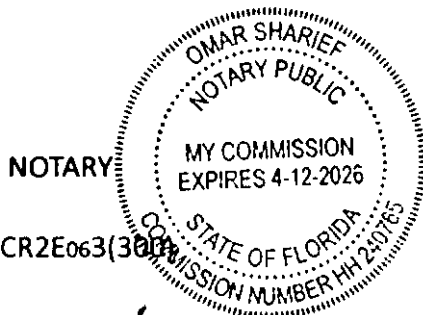

**AFFIDAVIT DECLARATION OF NATIONALITY ORDER TO SHOW CAUSE
FOR
RENUNCIATION**

It is my true intent to declare my name, race, and nationality, and it shall be expressed and filed into the trust minutes of the express trust so said and done.

Section 302 of Public Law 94-2414:

Any person who becomes a citizen of the United States solely by virtue of the provisions in **Section 301** [applying to those born in or residing in the Northern Mariana Islands] may within six months after the effective date of that Section or within six months after reaching the age of 18 years, whichever date is later, become a Taino Moor and an Americas Aboriginal National but **not a citizen of the United States** by making a declaration under the oath before an Equity Court of record established under **Common Law Jurisdiction of Florida as well as the Uniform Trustees Powers Act, Treaty of Peace and Friendship** in the form as follows:

"I, **Raoul Medina Jr** being duly sworn, hereby declare my intentions now and forever to be a Taino Moor/ Americas Aboriginal National but **not a citizen of the United States.**"

MY DECLARATION AND PROCLAMATION OF MY race shall reflect Taino Arawakan Boricua Moor and Nationality shall reflect Americas Aboriginal National and stand true in law, statutes, and jurisdiction within all courts of **Common Law rights and Jurisdiction.**





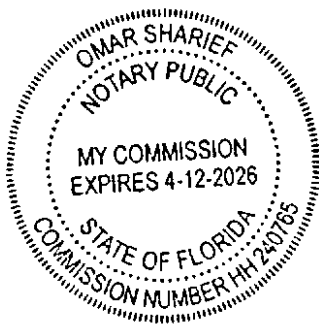

DECLARATION OF EXPRESS TRUST (A)

Established AUGUST 15, 2022, 1:11AM

THIS INDENTURE ("Agreement") made this 02nd day of October, 2022 serves as a Declaration of Express Trust and shall continue for a term of twenty-five (25) years from this day, between RAOUL MEDINA JR herein known as the settlor, and party of the first part, and Resul Medina Muhammad Bey & Najeebah A. Medina Bey Trustees, herein known as

the First Trustee or Trustees, party of the second part, under the name of:
TAINO MOORE TRIBE FOREIGN EXPRESS TRUST

EXPRESS TRUST, dba RAOUL MEDINA JR , Resul Medina Muhammad Bey , and HOODSTOCK LLC, RAW HEMP EDIBLES LLC, TAINO MOORE TRIBE LLC, 420 BROWARD LLC, NATURALLY CLEAN LOCS LLC OR AFTER HIP HOP TM , TAINO MOORE TRIBE LLC

CORPORATIONS. With this Contract, the Parties intended to create an Express Trust Organization for the benefit of the Trust Certificate Unit Holders and to identify, accumulate, purchase and hold any assets that become available and to provide for a prudent administration and distribution system administered by legal persons acting in a fiduciary capacity.

Whereas, the Settlor, irrevocably assigns and conveys to the Trustee(s), in trust, specific properties as defined in Minute (1-0001), to be made in future, this document in exchange for one-hundred (100) units of Beneficial Interest, known hereto as Trust Certificate (TCUs) to be held with this indenture by the Trustees for Beneficiaries also known as

Settlor: **RAOUL MEDINA JR** - (defined) In law a **settlor** is a person who settles property on **trust** law for the benefits of beneficiaries. In some legal systems, a **settlor** is also

referred to as a trustor, or occasionally, a grantor or donor.... A settlor may create a trust by manifesting an intention to create it. Grantor is the person who creates the trust.

Trust Protector: Resul Medina Muhammad Bey. A person other than trustee, or other person authorize in future by settlor, - (defined) appointed under the trust instrument to direct or restrain the trustees.

Trustee: (1st) Bey; Medina, A.Najeebah (2nd) Bey; Raoul Medina Jr. (defined) A person or firm that holds or administers property or assets for the benefit of a third party.

Beneficial Owner: Najeebah A. Medina Bey, Salah J. W. Medina Bey, Zakiyah E. W. Medina Bey. herein known as the First beneficiary, and other beneficiaries to come in the future (defined) **beneficial owner** is where specific property rights ("use and title") in equity belong to a person even though legal title of the property belongs to another person. This often relates where the legal title owner has implied trustee duties to the beneficial owner(s).

Other Beneficiary: Let It Be Known; other set beneficiary must have and be 1). Nationalize; 2). Must have a declaration of nationality Taino Moore 3). Must have a set title, El, Bey, Ali, Or Dey: All must follow beneficiary Rules 1). 2). And 3) **Keana Medina, Raoul A. P. Medina , Noah Medina, and Michael Anthony Medina.** Before they can REAP THE BENEFITS OF SET TRUST NO EXCEPTION.

WHEREAS, the Trust Organization is authorized to exist and function through its Board of trustees, comprised of the total active number of trustees who are legal persons who holding **fee simple title**, not differentiating between legal and equitable, not as individuals, but collectively as the Board, according to the inalienable and let it be known the Trust TAINO MOORE TRIBE F.E.T. Has a **PRIVATE SIDE** That has a **second DECLARATION (B) And Bylaws Let it be known That the (1st) First Trustee must renew All Corporations & Trust for no less than 25 years from the date He or She takes over as leading (1st) Trustee Common Law Rights.**


WHEREAS, The Trust shall be amendable, as described in the bylaws, and shall be irrevocable by the Settlor or any other person or entity but said trustee(s) can be fired by trust protector and replaced by new trustee(s) picked by trust protector. It is the attention of the Settlor to make the Beneficiaries, an absolute gift of the Trust Certificate Unit, in which the Beneficiaries shall not have any vested interest, until the termination of this Trust and final distribution accumulated assets or any early distribution of the assets thereof. There shall be exactly 100 Trust Certificate Units available to the Beneficiaries. The trust has not been **revoked, modified, or amended** in any way that would cause the representations in the trust certificate to be incorrect. This certification is being signed by current trustee(s) and is being executed in conformity with the provisions of **Common Law Rights.**

WHEREAS, The Trust shall be administered, managed, governed and regulated in all respects according to applicable (**Common Law Jurisdiction of Florida** as well as the


Uniform Trustees Powers Act, Treaty of Peace and Friendship). Common Law is the equity court, and the Express Trust can only be heard in Equity Court.

The domicile of the trust is within the Equity Court, in **Florida** in the republic of the United States of America as a last resort when everything else fails.





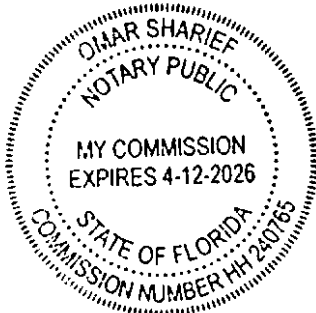
