- D. Section 6.1(c)2 is amended to read as follows:
 - 2. As provided in Section 9.9, cumulative voting applies to elections of Trustees.
- E. In Section 6.3(b) 4(ii) the number "11%" is changed to "10%."
- F. In Section 6.3(b) 5(ii) the number "11%" is changed to "10%."
- G. In Section 7.1 the word "Officers" wherever it appears is changed to "Affiliates."
- H. In Section 7.4(a) the following words are deleted: "the Officers, the Advisor" and "and underwriters selling the Trust's Shares (including broker-dealers selling the Trust's shares)" are deleted.
- I. In Section 7.4(a) A. the word "Indemnitee" is changed to "Trustees."
- J. In the last sentence of Section 7.4(b) after the word "Administrator", the following words are inserted: ", including the Tennessee Securities Division."
- K. In Section 7.4(c) the words "and Officers" are deleted.
- L. Section 7.4(e) is revised to read as follows:

and the Trust will not make any other loans whether secured or unsecured.

- Q. A new section 13.2(b)(14) is added as follows:
 - (14) Borrow to make distributions of Cash From Operations.

R. The second sentence in Section 18.2 is amended and revised to read as follows:

With respect to Shares owned by the Advisor, the Trustees, or their Affiliates, neither the Advisor, nor the Trustees, nor their Affiliates may vote or consent on matters submitted to shareholders regarding:

(i) the election of Independent Trustees;
(ii) changes to the Declaration of Trust;
(iii) approval or disapproval of contracts with Affiliates;
(iv) removal of any or all Trustees, or their Affiliates;
(v) dissolution of the Trust;
(vi) removal of the Advisor or its Affiliates; or
(vii) regarding any transaction between the Trust and any of the Advisors, the Trustees or their affiliates.
