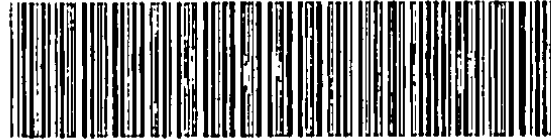

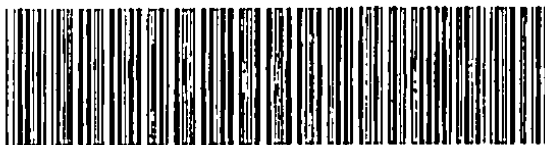

Second Amendment of Declaration of Trust
