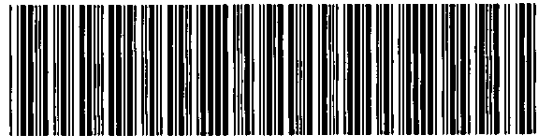




**ACCEPTANCE BY REGISTERED AGENT**


