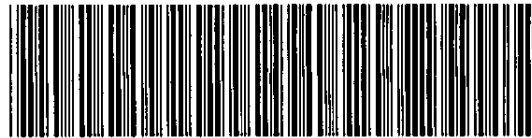


1. I am the Chairperson of the Board of Trustees, and an incumbent Trustee, of Miami Dade Leasing Trust-III-C (the "Trust").

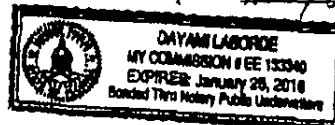
