- > Fees:

Renewal Filing fee Certified Copy (optional) \$87.50

\$ 8.75 (plus \$1 per page for each page over 8, not to exceed a maximum of \$52.50).

- Send one check for the total amount made payable to the Department of State.
- Please be sure to include a cover letter with your application and check. The cover letter should include the name of the contact person and his/her telephone number during the day, and the name and address to which the acknowledgment should be addressed.

A letter of acknowledgment is issued free of charge upon renewal. The filing of a renewal application renews the registration for the following calendar year.
