
Gentlemen/Ma'am,

A couple of days ago I received a normal piece of daily mail, but in parenthesis next to the company name it said "A Dissolved Florida Corporation". That statement shocked me and I went to the Department of State webpage, and sure enough it said "inactive".

I made a phone call to the company in Nevada that did all of our incorporation work (Nevada Corporate Planners) and they assured me that they had absolutely no record of receiving paperwork which involved the state of Florida, and that it sounded like a document that should have been mailed directly to me. I then called the Corporation Office for the State of Florida and was told that all papers are mailed to the Nevada office. At no time did we intend for our corporation to go inactive in the state of Florida as we do everything we can to make sure our papers are filed immediately.
