We recently filed for foreign corporation status in Florida. We entered a beginning date of the business as August 27, 1996 since we had filed the necessary tax documents from that time forward. When we were informed of the penalties for failing to register at that time, we reviewed the files supplied to us by the State of Florida to determine how we could have overlooked this issue.

When we inquired about doing business in Florida, none of the information we received indicated we needed to register with the Secretary of State. Most of the information we received came from the Department of Revenue and identified taxes we were responsible for paying and reporting. We did file all the necessary tax reports as they became due. (Enclosed are indexes of two of the publications we received.)

We also noted that our method of conducting business in Florida might not constitute transacting business under the Foreign Corporations Act since we only obtain orders in Florida. Our acceptance of those orders and advertising agreements actually occurs in Alabama where all of the paperwork and production processes are handled. (Please refer to Business Corporation Act, XV Foreign Corporations, 607.1501, 2(f).)

We would like to register as a foreign corporation in the state of Florida as of this date because we are now preparing to transact business that would require registration. We want to avoid any future questions about our ability to transact business within Florida.

Please advise us what steps we need to take to resolve this issue.



Obtain Required Licenses & Permits

he following guidelines provide basic information needed to begin any business in Florida as far as initial licenses, permits and registration requirements by local, state and federal government agencies are concerned.

A partial list of state licensing agencies and the businesses or occupations which they license, as well as a list of certain regulating agencies and the areas regulated, has been provided for additional information. No attempt has been made to provide a complete list of businesses or occupations licensed or areas which are regulated. The professions listed are based on the most frequently requested information. FEDERAL

940 Employer's Annual Unemployment Tax Return

Used to report and pay, on an annual basis, the federal unemployment compensation tax. If a business does not have employees, this form is not needed.

941 Employer's Quarterly Federal Tax Return

Used to report, on a quarterly basis, the income tax and social security withheld from employees' wages and the social security matched by the employer.

Other Federal Forms

Specially regulated industries such as liquor and firearms are required to file other federal forms periodically. The regulatory agency will provide the appropriate reporting requirements.

SS-4 Application for Employer Identification Number

When this form is properly completed

and submitted to the Internal Revenue Service, it registers a business with the federal government. With the exception of a sole proprietor, this registration is required even though a business may not have employees. The form must be filed on or before the seventh day after the date on which business begins.


DR-1 Application for Certificate of Registration (Sales Tax Number)

The State of Florida requires collection of a 6% retail sales tax on most items, and the sale, resale or lease of tangible personal property or the rental of real property. Many Florida counties also have a discretionary tax (1/2% or 1%) collected by the Department of Revenue, All businesses which collect the sales tax must secure a Certificate of Registration (sales tax number) from the Department of Revenue. A \$5.00 registration fee is required for Florida businesses. A business found operating without being registered may be required by the Department of Revenue to pay a \$100.00 registration fee. Anyone reporting a non-registered business which is required to register may receive a \$100.00 reward.

DR-15 Sales and Use Tax Report

Used to report and pay monthly the state sales tax collected. When the report and payment are submitted correctly and on time, the dealer retains a collection allowance of 2.5% of the first \$1,200 of tax submitted, a maximum of \$30.00 per return.

DR-601-C Intangible Personal Property Tax Return (Corporations and Partnerships)



DR-601-I Intangible Personal Property Tax Return (Individual and Fiduciary)

Used to report and pay tax annually on intangible property such as accounts receivable, stocks and bonds, notes and loans. Tax is due by June 30 for value of intangibles owned on January 1.

Corporate Income Tax

This is to be filed only if a business is a corporation. General or limited partnerships are not subject to this tax unless one partner is a corporation, in which case a Florida partnership return must be filed. S Corporations file the first year of business in Florida, but are often exempted in subsequent years.

UCS-1 Report to Determine Status

Used to determine if the employer is liable for unemployment compensation taxes and to apply for a state unemployment compensation tax number.

UCT-6 Unemployment Compensation Tax Return

Used to report and pay quarterly employer's unemployment compensation tax based on employees' wages. This is paid to the State Unemployment

Compensation Fund, not to be confused with workers' compensation insurance.

DR-405 Tangible Personal Property Tax Report

Used to report tangible personal property (equipment, furniture, etc.), livestock and inventory on an annual basis. Check with the county property appraiser.

Local Occupational Licenses


Occupational licenses are required for each business location and are issued by most Florida counties and cities. These licenses are considered local option taxes. Both a city and county occupational license may be needed, depending on local laws and the location in Florida. Check with the tax collector's office in the county in which the business is located and the city clerk to determine which licenses are needed.

Certificate of Occupancy

After a business location has been selected, a certificate of occupancy must be obtained. Check with the city building inspection division to determine which forms are needed for the particular business.

Zoning Permits (Certificate of Use)

Check with the county planning department or building inspection division to determine which forms are needed for the particular business location.






