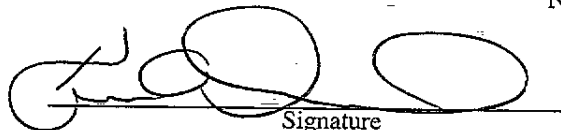

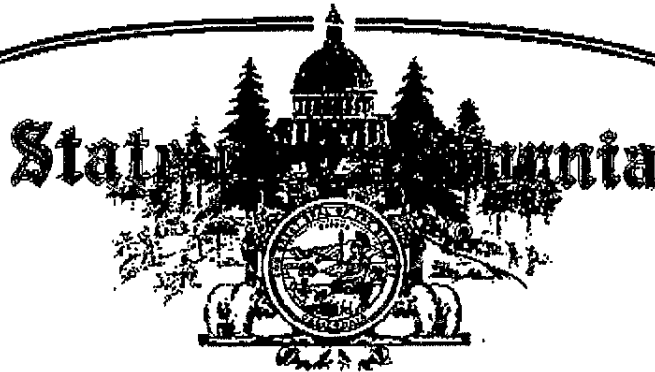

AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
ENTERPRISE NETWORKING SYSTEMS, INC.**

Will Clark and Stephen C. Farrell hereby certify as follows:

ONE: They are the duly elected and acting President and Secretary, respectively, of
Enterprise Networking Systems, Inc. (the "Corporation").

TWO: Article I of the Articles of Incorporation of the Corporation is hereby amended to
read in full as follows:

"ARTICLE I

The name of this corporation (the "Corporation") is "Netigy Corporation."

THREE: The foregoing amendment has been approved by the Board of Directors of the
Corporation.

FOUR: The foregoing amendment was approved by the holders of more than 50% of the
outstanding shares of the Corporation in accordance with Sections 902 and 903 of the California
General Corporation Law. The total number of outstanding shares entitled to vote with respect to
the foregoing amendment was 14,939,038 shares of Common Stock, 11,742,000 shares of Series
A Preferred Stock and 1,009,652 shares of Series B Preferred Stock, voting together as a single
class.
