With this letter of explanation, I have enclosed a check in the amount of one hundred and fifty dollars (\$150.00) and another completed Annual Business Report Form, again, this time via registered mail. On October 11, 2001, our company received a Notice of Administrative Dissolution or Revocation on our corporation, for reportedly failing to submit the aforementioned items in a timely manner.

In the latter part of April 2001, I dutifully mailed our Annual Business Report Form accompanied with a money order in the amount of \$150.00. It was not until I received the Notice of Administrative Dissolution or Revocation that I was made aware that the Division of Corporations had apparently not received the previously sent items.

Prior to October 11, 2001, I had assumed that our corporation was still in good standing in the State of Florida. We have since been informed that the Division of Corporations does not send out an acknowledgement of receipt of those items.



We are a small Delaware Corporation (in good standing in Delaware) who had applied and was accepted just last year to conduct business in Florida. I am not requesting to have any fees waived or exceptions made. Instead, my request is that if our business report and money order were lost, that the enclosed documents, being sent in place of those previously lost, be processed accordingly. We have apparently already lost \$150.00 and the thought of having to pay an additional \$750.00 for reinstatement fee seems excessive for a small company. I'm sure you can appreciate that fact!
