We are sorry to have to return this filing a second time, and we thank you for the letter of explanation that both the Illinois and the Delaware corporation are owned by the same people.

However, the problem is that BOTH CORPORATIONS have EXACTLY THE SAME NAME. Under Florida law, we cannot allow the registration of TWO CORPORATIONS with EXACTLY THE SAME NAME.

So if you don't wish to change the name of one of the corporations in its home state, you will have to adopt an ALTERNATE CORPORATE NAME for the Illinois corporation to use in Florida -- something like "FLORIDA RECYCLING SERVICES OF ILLINOIS, INC." And you are going to have to submit a resolution of the board of directors -- see our attached form -- adopting that name for use in Florida.
