In response to our telephone conversation today, and your letter (number 900A00008466), we protest the imposition of \$ 26,916.25 in fees and penalties against EURPAC for failing to file proper state registration. Eurpac has made every effort to comply with Florida Statues including filing sales, property, and withholding taxes in addition to occupation licenses. This problem arose when we tried to RENEW our occupation license for the City of Atlantic Beach. Certainly we should not have been issued the original occupation license without properly registering with the state.

Our company has in no way intentionally violated any statues; we think that this problem is due only to oversight and therefore request that penalties be abated. I understand from our conversation that this letter will be forwarded to your attorney for consideration.

COMMENTS: This communication is further to our recent conversation regarding charter taxes, annual report fees and statutory penalties which would be assessed against Eurpac Services, Inc., under section 607.1502(4), Florida Statutes.

An application filed with the Division of Corporations indicates Eurpac Service, Inc. has transacted business in Florida since 1970. Accordingly, excluding applicable charter taxes and filing fees, an amount of \$26,916.25 is due, reflecting annual report fees of \$1916.25 and statutory penalties of \$25000.00. We would, however, in the interests of avoiding litigation, offer to settle the issue of annual report fees and foreign non-qualified penalties from Eurpac Service, Inc. for the sum of \$10249.58,

reflecting annual report fees from 1970 of \$1916.25 and penalties from 1970 of \$8333.33 assessed in a lump sum to avoid litigation. This sum excludes rather minor filing fees and applicable charter taxes. I have asked the Division of Corporations to fax you a form for the calculation of applicable charter taxes. The filing fee is \$70.00.

This offer remains in effect until April 28, 2000. Upon completion of the application and receipt of a check in that amount payable to the Department of State, Division of Corporations, I will instruct the Division of Corporations to issue Eurpac Service, Inc. a Certificate of Authority to transact business in Florida.
