

On February 21, Pinner Transportation, Inc. received a letter (number 200A00009097) from the Division of Corporations indicating that Pinner Transportation, Inc.'s authorization to transact business in Florida as a foreign corporation would require the payment of civil penalty of \$1,000.00 for each year this entity transacted business in Florida prior to qualification.

At this time, Pinner Transportation, Inc., may not require the authority of the Florida Department of State to transact business in Florida. Pinner Transportation, Inc. is a Georgia Corporation which is engaged in the business of transporting textile products to Florida. Pinner Transportation, Inc. has been issued a motor carrier registration number (MC 150065) from the Federal Department of Transportation. Furthermore, Pinner Transportation, Inc. is engaged entirely in transacting business in interstate commerce. Pursuant to Section 607.1501(2)(i) of the Florida Statutes, Pinner Transportation, Inc. do not constitute transacting business within the State of Florida.

Please consider these facts and inform us of you opinion as to the meaning of the relevant section of the Florida Statutes.

Even if Pinner Transportation, Inc. should apply for authority to transact business in Florida as a foreign corporation, we respectfully request that you consider imposing the minimum penalty rather than the maximum penalty pursuant to section 607.1502(4) and 617.1502(4) of the Florida Statutes. Please let us know the criteria you use to determine the appropriate penalty to be assessed under these sections.
