Thank you for your telephone call of this morning. I appreciate your so promptly returning my call and advising that it would be permissible for our firm to submit a letter clarifying that New South Financial Services, Inc. ("New South") has not yet transacted business in Florida pursuant to Florida statutory law. We drafted Exhibit B to New South's application for Authorization to Transact Business in a manner to give your office (as well as the Department of Banking and Finance) a full understanding of New South's previous and future operations. We apologize that this raised an issue regarding the unauthorized transaction of business in your state.

Thank you for waiving the requirement for an affidavit set forth in your letter of April 19, 2000. Although, I had already dictated such an affidavit for execution by New South, it will speed matters up considerably for you to rely upon this letter. Therefore, to reiterate and to clarify, New South has not yet transacted business in Florida, and it does not anticipate doing so within the meaning of Florida Statutes §607.1501 until July, 2000. The activities conducted by New South to date do not constitute transacting business within the meaning of Florida Statutes §607.1501(1) pursuant to language set forth in Florida Statutes §607.1501(2)(g) and (h).

Statement

NewSouth Financial Services, Inc. ("NewSouth") began doing business in Florida in August 1998. NewSouth originates first and second residential mortgage loans on a wholesale basis through brokers operating in Florida.

NewSouth currently does not have offices in the state of Florida, although it plans to open a retail office in July 2000 (Estimated) to originate first and second mortgage loans, consumer loans (including loans of less than \$25,000.00 at rates greater that 18%) and to purchase retail installment contracts.

NewSouth is currently a wholly owned operating subsidiary of First Liberty Bank, Macon, Georgia. First Liberty Bank is a Federal Thrift. As a wholly owned operating subsidiary of a Federal Thrift institution, NewSouth is exempt from state law addressing lending activities by virtue of Federal Regulatory and statutory provisions and related opinions of the office of General Counsel of the Office of Thrift Supervision.

Effective May 20, 2000, NewSouth will become a wholly owned subsidiary of Branch Banking and Trust Company, Winston Salem, North Carolina by virtue of the merger of First Liberty Bank in to Branch Banking and Trust Company. Branch Banking and Trust Company is a North Carolina state-chartered bank. Following this transaction, NewSouth will not enjoy the preemption previously described.
