Dear Sir-or Madam:

Attached is the 2001 Uniform Business Report for my corporation, MyGenes.Com, Inc. This is the first filing of the UBR since we are a Maryland corporation who recently began doing business in Florida. We registered as a Florida Foreign corporation in 2000 but did not receive the initial mailing of this tax form.

We respectfully request abatement of the \$400 late filing penalty for reasonable cause. Although we filed our 2001 form late it was due to two factors beyond our control. First, we were not aware of the existence of this annual form since this is the first year we were required to file the form. Second, we never received the original form by mail and therefore were not aware that we owed this tax.

We have attached a check for \$150 in payment of the tax owed as of May 1<sup>st</sup> and ask that you abate the late penalty of \$400 for reasonable cause.
