



ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF KOHL, GRAMIGNA ARCHITECTS, INC.

The Articles of Incorporation of KOHL, GRAMIGNA ARCHITECTS, INC. shall be amended as follows:

1.

The name of the corporation is changed to KOHL, GRAMIGNA, MONARDO ARCHITECTS, P.C.

2.

The Corporation will be engaged in the practice of architecture, and hereby elects to be governed by the provisions of the Georgia Professional Corporation Act. The Corporation is a corporation for profit, and is organized for the following purposes: Subject to the restrictions or limitations imposed by law, to purchase or otherwise acquire, hold, own, sell, assign, transfer, create security interests in, pledge, exchange or otherwise dispose of the shares, bonds, obligations, or other securities or evidences of indebtedness or other corporations, domestic and foreign, and the goodwill, rights, assets and property of any and every kind or any part thereof, of any person, firm or corporation, domestic and foreign, and if desirable, to issue in exchange therefor the shares, bonds, or other obligations of this Corporation, and while the owner of such shares to exercise all rights, powers and privileges of ownership, including the power to vote thereon. Also, to engage in any lawful act or activity for which corporations may be organized under the provisions of the Georgia Business Corporation Code (Georgia Professional Corporation Act).

This amendment was adopted by the Board of Directors and the shareholders of the Corporation on Jan. 1, 2002, a copy of which is attached hereto.
