


Dennis M. Hamilton, being duly sworn states as follows:



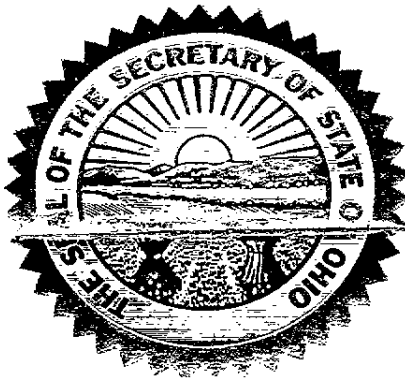
