In May, 1999, CBORD received from the Florida Department of Revenue an Intangible Tax Self Audit. CBORD was advised it was required to obtain authority to do business as a foreign corporation in Florida to participate in the self audit. CBORD immediately sent an executed application for authorization to transact business in Florida. In response, it received a letter from you advising that fees and penalties totaling \$3,465.00 were due and payable.

CBORD has been engaged in certain activities within Florida since 1996. It has attempted to comply with all requirements of Florida law continuously during that entire time period. For example, it applied for and received a sales tax identification number in or around April, 1996. It has also filed Florida corporate tax returns beginning with tax year 1996.


Because CBORD has attempted to comply with, and not circumvent, all applicable provisions of Florida Law of which it was aware, we respectfully request that the penalty for failure to obtain authorization to conduct business be reduced to the minimum set forth in Florida Statutes §607.1502(4), or \$500.00 per year. Please advise whether the requested deduction in penalties will be granted and provide an itemized summary of amounts then due from CBORD.
