of further help please let me know.

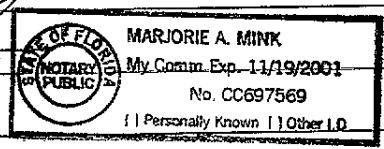

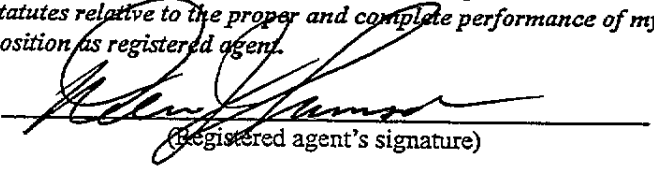
