We would like to request for the waiver of the penalty and interest being charged to our charter # F00000002693. Your records indicate that our corporation's certificate of authority was revoked for failure to file the required Uniform Business Report. The first time that we received the authority to transact business in Florida was on May 11, 2000 and this was for three (3) temporary employees working in Florida.

Unfortunately, we would like to inform you that we have not received an Annual Report Form or any notice or form about the filing of the Uniform Business Report for Years 2001 and 2002. This is the first time that we learned about this requirement. We also would like to point out that we did not have any employees in Florida from January to September 2001 and the account #2242007-0 was de-activated with the Florida Dept. of Revenue effective January 1, 2001. The account got re-activated in October 1, 2001 and we have had only three (3) temporary employees working in Florida from October 2001 up to the present.
