Dear Sir/Madam:

On July 8, 2002, RNK Telecom, Inc. ("RNK") received notice of its delinquency in filing the 2002 Uniform Business Report ("UBR") with the Florida Department of State ("Department"). RNK does not refute its delinquency, but respectfully requests that the Department waive the \$400.00 late fee for the reasons explained below. Pending the Department's decision, enclosed please find RNK's completed 2002 UBR, and RNK's check for \$150.00 as payment of the original filing fee.

For some background, RNK is a successful competitive local exchange carrier offering telecommunications services to residential and business customers in New England and various other states throughout the United States with its principal place of business in Massachusetts. RNK obtained business authority in Florida on May 26, 2000 with the expectation of offering services in Florida. However, business necessity and the economy forced RNK to delay its plans to offer services in Florida, and as such, RNK suspended efforts to obtain certification from the Florida Public Services Commission. As a result, RNK also requested and obtained inactive Sales Tax status on March 31, 2001. Recently, RNK has been able to resurrect its plans to offer service in Florida, and accordingly, its plans to obtain a certificate of Public Convenience and Necessity from the Florida Public Services Commission. RNK plans to file the certificate within a few months and hopes to be offering its competitive services to the people of Florida very soon.

In addition to business and economic factors, RNK was also recently forced to terminate the individual responsible for regulatory and corporate compliance in Florida for, among other reasons, poor handling of nuandatory filings with States and Public Utilities Commissions. The resulting period of confusion prior to and after termination made it difficult for RNK to determine exactly which filings were delinquent until very recently. Predictably, RNK was unaware it had failed to file its 2002 UBR until it received notice from the Department on July 8, 2002. In response to this notice, RNK has taken immediate action to contact the Department, submit the appropriate paperwork, and pay the annual fee:
