Please note that we are STILL RETAINING your \$70.00 payment.

Back in April, we asked that you please add a corporate suffix to the name "FIRST ACCESS, LTD." Had you done that, and had you listed a name such as FIRST ACCESS, LTD., INC. on the first line of your application, that name would have been acceptable to us. Because under our name rules, the "LTD." suffix contained in your name would have DISTINGUISHED the name from the name of a Florida corporation called FIRST ACCESS, INC.

However instead of adding the suffix as requested, this corporation apparently changed its name in the Cayman Islands to FIRST ACCESS CORP.

The name FIRST ACCESS CORP. is NOT AVAILABLE in Florida because it conflicts with FIRST ACCESS, INC.

Please note that FIRST ACCESS, INC. was Administratively Dissolved on 9/24/1999, but we are required by law to reserve that name for a period of 1 year so that the corporation may reinstate.

If the name of your Cayman Islands corporation is now FIRST ACCESS CORP., then the corporation will have to complete a Resolution of the Board of Directors, and will have to adopt an ALTERNATE CORPORATE NAME for doing business in Florida.

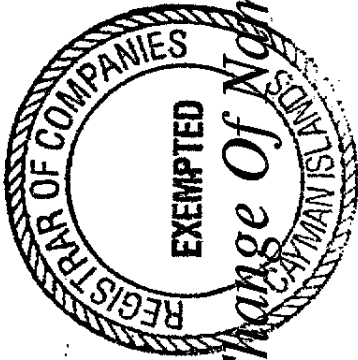

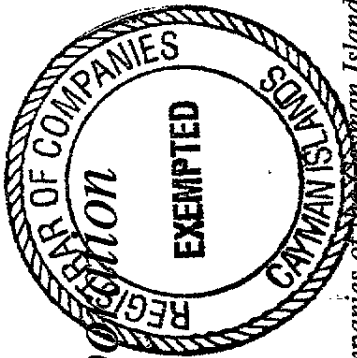
